Check-In and Check-Out reservations are *by appointment only during designated hours*. There will be **\$30.00 fee charged** for any changes to scheduled reservation after initial appointment is made (see Reservation Changes).

_____ Initials - Vaccinations **required** are Bordetella, Rabies, DHPP (Distemper, Adenovirus, Parainfluenza, Parvovirus). Owner must provide proof of current vaccinations **on or before Check-In date**. Owner acknowledges vaccinations decrease risk of disease however infection is still possible without further liability on the part of K9.

Owner is responsible for providing food for dog's reserved stay. Food must be in a sealable container/bin, no plastic bags. If additional food is needed, Owner agrees to reimburse K9 Country Club, LLC for this expense.

If dog(s) require medication, Owner will provide **veterinarian dispensed medication bottle** with written detailed instructions on medication administration to K9 Country Club, LLC at time of Check-In appointment.

Owner assumes all risk associated with using the services at K9 Country Club, LLC which include but not limited to illness, disease, or injury to self or other pets and damage to K9 Country Club, LLC. I release and indemnify K9 Country Club, LLC and its owner from all actions, suits or claims for injury, loss or damage regardless of the cause.

Owner accepts full financial responsibility for all repairs, if dog(s) becomes destructive to K9 Country Club, LLC property.

Owner does hereby authorize us to obtain the services of a veterinarian in the event dog(s) require, or in judgment of our personnel, appears to require medical attention and we shall select a veterinarian to provide medical services. Owner agrees to be responsible for all such veterinarian expense and to pay all such expenses at time of scheduled Check-Out.

Owner agrees to pay all charges due at time of Check-Out and before dog(s) leaves K9 Country Club, LLC. Any dog(s) not claimed within 7 days of scheduled Check-Out date shall be released to Emergency contact listed above or to such authorities as we may select, without further liability on the part of K9 Country Club, LLC. Owner shall be responsible for all such additional boarding and care charges plus the reasonable costs and charges incurred in releasing dogs to such authorities.

Owner agrees to allow K9 Country Club, LLC to use pictures of dog(s) for advertising purposes to include but not limited to social media, printed/digital advertising or brochures.

RESERVATIONS

Credit card is required to book a reservation. A \$50.00 non-refundable fee is charged at the time of reservation and would be applied as credit if reservation is fulfilled as scheduled.

NO SHOW / CANCELLATION POLICY / RESERVATION CHANGES

No Show - If you do not show for your scheduled check-in appointment, a fee amounting to the **total cost of the reserved service** will be charged to credit card on file.

Cancellation of a booked reservation will require an email sent to k9countryclubllc@gmail.com notifying us of your cancellation. ***Any cancellation made less than 72 hours in advance of scheduled Check-In appointment will result in a cancellation fee.*** The amount of the fee will be equal to 50% of the reserved service and will be charged to credit card on file.

Reservation Changes are any changes after initial reservation has been made. Changes are subject to availability and ***will result in a \$30 change fee*** to be charged to credit card on file.

Owner whose signature appears on this agreement, warrants that he/she is the dog(s) owner and/or is authorized to enter into this agreement (must be 18 years or older). By signing this agreement, Owner agrees with terms and conditions of this contract. Boarding Agreement/contract is valid for 1 year from signature date.
